Human Rights Day Lecture

With Historical Memory as the Key, Taiwan Stands Against Authoritarianism

On December 10, 2024, the Control Yuan (CY) National Human Rights Commission (NHRC) and the French Office in Taipei co-hosted a special lecture for Human Rights Day 2024, “The Struggle for Historical Truth and Human Rights in Authoritarian Regimes.” The event featured Dr. Nicolas Werth, Chairperson of International Memorial, and Ms. Alexandra Polivanova, a representative of the organization, who shared their experiences in advancing human rights under authoritarian rule.

International Memorial is a Russian human rights nonprofit organization founded in 1987, dedicated to documenting and exposing the history of political oppression in the USSR and modern Russia. In recognition of its efforts, it was awarded the Nobel Peace Prize in 2022.

CY President and NHRC Chairperson Chen Chu emphasized that human rights are not just a one-day commemoration but a fundamental responsibility for Taiwan as a member of the global community. She also praised International Memorial’s efforts in verifying lists of political prisoners and preserving historical archives, serving as a valuable reference for Taiwan in advancing transitional justice and history education. 🇹🇼

NHRC hosted the awards ceremony for the “Color Our Rights: 2024 Human Rights Poster Design Competition” on December 8, 2024 at the Red House in Ximen, Taipei. This year focused on the theme of “Equality and Non-Discrimination” and, for the first time, invited international submissions through Taiwan’s overseas missions. The event received 1,365 entries from creators around the world, including participants from the UK, Finland, Portugal, and several Southeast Asian countries.

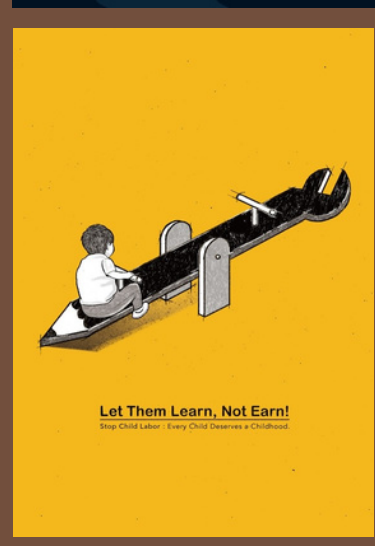
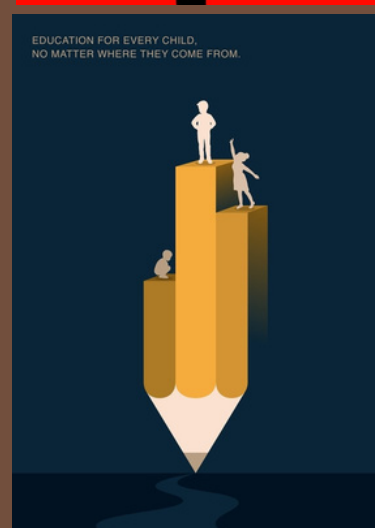
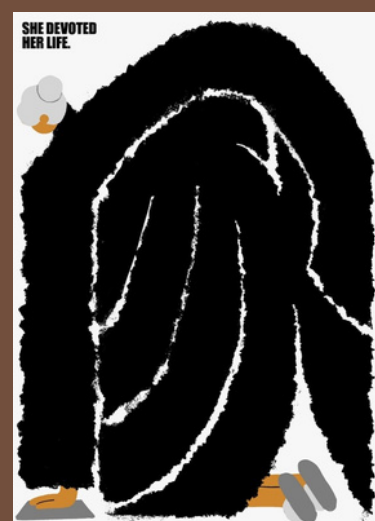

NHRC Releases Systematic Inquiry Report on Child and Youth Sexual Abuse Cases

On 8 January 2025, NHRC held a press conference to release its special report, “Your Voice Plants the Seeds of Change - Systematic Inquiry Report on Sexual Abuse in Schools and Placement Institutions.” NHRC announced the investigation results and called on society to acknowledge and prioritize the voices and feeling of children and youth, jointly building an environment of support and trust.

NHRC unveils systematic inquiry report on child and youth sexual abuse, urging stronger protection measures (8 January 2025)

Vice Chairperson Wang Yu-Ling emphasized the urgency of child and youth protection. The report revealed that 80% of the 74 interviewed victims only disclosed their abuse years later, reflecting barriers to seeking help and inadequate support systems. She particularly thanked all interviewees for bravely sharing their experiences and underscored the need for systematic reforms to create a safe and nurturing environment for children and youth. 2024 Short Film Competition

Short for Human Rights

Capturing Taiwan's Human Rights Vibrancy in One Minute

To enhance public awareness of human rights and make effective use of online social media platforms, NHRC launched its first-ever "Short for Human Rights - 2024 Short Film Competition", encouraging students and the general public to express human rights ideas through one-minute videos.

The award ceremony, co-hosted by NHRC Vice Chairperson Wang Yu-Ling and CY Vice President Lee Hung-Chun, was held on May 25 the Chang Yung-Fa Foundation International Convention Center. Award winners and their families were invited to attend, as 23 winning entries from both, including the student and general categories, were revealed and showcased along with the creators' concepts and video content.

Notably, several outstanding entries were submitted by high school students, indicating that human rights thinking has taken root among the younger generation. The Gold Award in the student category went to Hao Yi-Fen for "What Happened?", an abstract and artistically rendered portrayal of the emotional challenges faced by individuals with dementia and

their caregivers. The work received unanimous praise acclaim from the judging panel.

Furthermore, People's Choice Awards were selected through online voting. The award went to a film illustrating the daily school life of autistic students in the student category. In the general category, the winner explored the revival of indigenous clothing traditions by contrasting generational perspectives. ￼

VP Lee expressed gratitude for the delegate’s enduring connection to Taiwan and their ongoing advocacy for education and remembrance of the 228 Incident. Global Engagement

For the first time, RightsCon, the global digital human rights conference, was held in Taiwan. On February 24, 2025, the National Human Rights Commission (NHRC) and the Philippine Commission on Human Rights (CHR) co-hosted the “2025 Digital Human Rights International Workshop” to explore digital rights and policy strategies.

NHRC Vice Chairperson Wang Yu-Ling highlighted concerns about AI’s impact on marginalized communities, including algorithmic discrimination, privacy risks, and labor conditions. NHRC Commissioner Lin Wen-Cheng stressed the need to mitigate discrimination risks, enhance transparency, and conduct human rights impact assessments in Taiwan’s draft “Basic Act on AI.”

The workshop gathered representatives from foreign institutions and NGOs in Taiwan. Philippine CHR Commissioner Beda Angeles Epres called for joint strategies among national human rights institutions, while Commissioner Faydah Maniri Dumarpa emphasized digital rights as an essential extension of human rights and urged stronger protection policies for human rights defenders. 🇵🇭

AI for Equality

NHRC and Australian AI Expert Dr. Keay Exchange Insights on Gender and Technology



while AI development may exacerbate digital divides, it offers new opportunities for preserving Indigenous languages

On March 5, 2025, Dr. Sue Keay, Director of the AI Institute at the University of New South Wales, and Robert Fergusson, Representative of the Australian Office, visited the National Human Rights Commission (NHRC). They held in-depth discussions with NHRC Vice Chairperson Wang Yu-ling and other commissioners on topics including gender equality, women's empowerment, Taiwan's progress on the Artificial Intelligence (AI) Fundamental Act, and the role of AI in preserving Indigenous languages.

Vice Chairperson Wang emphasized the shared commitment of Taiwan and Australia to universal human rights values. She reaffirmed the NHRC's dedication to monitoring the implementation of international human rights standards in Taiwan and expressed hope for closer cooperation with Australia in promoting global human rights advancement.

Dr. Keay highlighted the persistent gender gap in science and technology, stressing the importance of education in sparking interest and boosting participation

among women. She also noted that while AI development may exacerbate digital divides, it offers new opportunities for preserving Indigenous languages. Drawing from Australia's own experiences with language loss, she pointed to Taiwan's TAIDE (Trustworthy AI Dialogue Engine) initiative as a promising model for using AI in cultural and linguistic preservation. 🇺🇸

NHRC Welcomes Luxembourg Parliamentarians, Deepen Taiwan–Luxembourg Human Rights Exchange

A delegation of four Members of the Luxembourg Chamber of Deputies, led by MP Stéphanie Weydert and including MP Ben Polidori, Liz Braz, and Ricardo Marques, visited NHRC on April 8, 2025. NHRC Vice Chairperson Wang Yu-Ling welcomed the delegation, accompanied by Commissioners Lin Wen-Cheng and Yeh Yi-Jin. Both sides engaged in discussions on a range of topics, including the development of human rights in their respective countries, the rights of migrant workers, juvenile delinquency, and the abolition of the death penalty.

MP Braz noted that human trafficking and juvenile delinquency remain significant human rights challenges in Luxembourg. The delegation also expressed interest in Taiwan's progress toward abolishing the death penalty and the livelihood of migrant workers. NHRC reaffirmed its long-standing position in support of abolishing the death penalty. While recognizing the lack of social consensus on the issue, NHRC emphasized its commitments to fostering public dialogue.

Regarding issues such as the mistreatment of domestic migrant workers, exploitative conditions faced by foreign fishermen, and undocumented migrant workers who are pregnant or raising children, NHRC will continue to monitor these issues and has

urged the government to uphold migrant workers' rights in accordance with international human rights standards.

Vice Chairperson Wang emphasized that Luxembourg and Taiwan both share the universal values of freedom and democracy. According to “Freedom in the World 2025”, published by Freedom House, both countries ranked among the highest, with Luxembourg scoring 97 and Taiwan 94. Wang underlines that “Human rights are a never-ending pursuit”. There is no perfect score, but we look forward to working alongside like-minded international partners to advance human rights worldwide. 🇹🇼

Control Yuan Attends First Virtual Meeting of the IOI Standing By-Laws Committee

On April 23, 2025, Member Lin Wen-Cheng, convener of the CY's International Affairs Committee (IAC), represented the CY at the first virtual meeting of the International Ombudsman Institute (IOI) Standing By-laws Committee ("the Committee"). Since joining the IOI in 1994, the CY has actively participated in IOI activities to fulfill its membership obligations. In January 2025, when the IOI Secretariat invited expressions of interest for Committee membership, the CY volunteered to serve as a member on the Committee.

The term for the current Committee members runs from 2024 to 2028. In addition to the CY, represented by President Chen Chu, the Committee members include: Ms. Nasheli Ramírez Hernández, IOI President and President of the Human Rights Commission of Mexico City; Mr. Chul-Whan Ryu,

Chairman of the Anti-Corruption and Civil Rights Commission of South Korea; Mr. Reinier Van Zutphen, National Ombudsman of the Netherlands; Mr. Joseph Zammit Mckeon, Parliamentary Ombudsman of Malta. The Committee is chaired by Mr. Chan Jick-chi Jack, Ombudsman of Hong Kong, while the IOI General Secretariat serves as an observer and provides executive assistance.

At this inaugural virtual meeting, Committee members engaged in meaningful exchanges and in-depth discussions. English was adopted as the Committee's working language, and its terms of reference were formally confirmed. The IOI General Secretariat also provided a brief update on proposed by-law amendments. The second

meeting was held on May 12, 2025 in Rabat, Morocco, in a hybrid format. The CY remains committed to contributing actively to the Committee and advancing the IOI mission. 🇹🇼
