Participants exchanged ideas on issues including the abolition of the death penalty and rights of migrant workers. The visitors received affirmation and support from France and Germany. Chen added that Taiwan would continue to let the world know about its efforts to promote human rights.

Discussion focused on the three main challenges in Latin America—human rights, rising inequality, and digitalization. Member Lai Chen-chang represented the CY at the 26th annual assembly of the Ibero-American Federation of Ombudsmen (FIO) in Mexico City from November 28 to December 1, 2022. The FIO annual assembly was attended by over 150 people from at least 21 countries. Participants discussed the characteristics of ombudsmen systems in different countries and shared experiences of working practices.

The theme of the conference was "Remaining Relevant and Getting Government to Listen." CY President Chen was invited to present at the session "Influencing an integrity and human rights agenda," discussing influencing government while remaining above the political fray.

The conference coincided with celebrations to mark the 60th anniversary of the Ombudsman in New Zealand, and the delegation was invited to the ceremony held at Parliament House. The delegates also visited the Office of the Ombudsman and the New Zealand Human Rights Commission and had fruitful exchanges and discussions on both supervisory experiences and human rights systems.

4 Powers & Duties

The Control Yuan inspected the Executive Yuan on December 23, 2022 with CY President Chen Chu leading the entire CY membership on the circuit supervision.

Chen pointed out the equal treatment for migrant workers Given that there are currently 710,000 migrant workers in Taiwan, it is vitally important that they receive due rights and assistance. "I hope the CY and the National Human Rights Commission can cooperate with the EY," said Chen.

and unregistered children, school accessibility, and name correction of plains indigenous peoples etc. Su and relevant agency heads were asked to give immediate responses.

The CY expects the EY to supervise government agencies By studying the suggestions collected by the CY, the two branches hope to make improvements, and work together to serve the people of Taiwan and meet their expectations.

On July 21 and 22, the Control Yuan (CY) held a conference on the new era of supervision and human rights investigations. The CY President, Vice President, and all its members took part in a general discussion to impartially address several administrative issues. The aim of the conversation was to improve the smooth operations of the CY and pave the way to openness reform.

The event also covered issues of data security and

Grand Justice Introduces New Court Procedures



The Constitutional Court Procedure Act formally came into effect. On October 17, the Control Yuan's Committee on Judicial and Prison Administration Affairs invited Grand Justice Hwang Jau-yuan to give a talk on the newly implemented procedures for the Constitutional Court.



Grand Justice Hwang explained how the highest state organs can exercise their powers and lodge petitions. CY members and staff actively took part and asked lots of questions, ensuring that the lecture finished on a high note.

NHRC Chairperson Chen Thanks Pelosi for Past Human Rights Assistance

On August 3, Chen Chu, Chairperson of the National Human Rights Commission, gave Nancy Pelosi a tour of the Jingmei White Terror Memorial Park. Chen said the United States had played a key role in promoting the process of democratization in Taiwan.



Chen said it was deeply significant to meet Pelosi in the military courtroom where she was tried. Pelosi said it represents how democracies must learn from their past mistakes to stop history repeating itself in the future. In late 1979, a group of opposition leaders held speeches to mark International Human Rights Day. The event was broken up by military police, leading to a conflict with the participants that became known as the Kaohsiung Incident.

In the aftermath, well-known opposition leaders were imprisoned, including Chen. Overseas Taiwanese organized a campaign to help the accused by bringing them to the attention of mainstream American society and media. This saved the dissidents from the death penalty. The incident was a watershed moment for Taiwan's democracy movement.





Chairperson of the National Human Rights Commission (NHRC) Chen Chu, addressed a forum on September 8 about creating genderfriendly workplaces and achieving corporate inclusion and sustainability.

The Act of Gender Equality in Employment was formally implemented exactly 20 years ago, in 2002. "For someone of my generation," added Chen, "it has been very gratifying to see companies take concrete steps to support female employees in taking care of their families."



On August 2, 2022, President Tsai Ing-wen attended the 2022 Indigenous Peoples Rights Forum. Speaking at the event, she expressed the hope that the National Human Rights Commission (NHRC) would maintain its independence, align itself with international human rights standards, promote understanding of indigenous rights within Taiwanese society, learn from indigenous peoples, and pay homage to them.

NHRC Chairperson Chen Chu said the NHRC would cooperate with the Executive Yuan and civil society organizations in the second half of the year to promote indigenous rights education in colleges and universities nationwide, to achieve indigenous human rights protections.

The forum was cohosted by the NHRC and the Council of Indigenous Peoples. Held at the Grand Hotel in Taipei, the venue was filled with indigenous representatives. Guests included Premier Su Tseng-chang, Control Yuan Vice President Lee Hung-chun, and members of the diplomatic corps.

Taiwan and France Sign Agreement on

politics, indigenous peoples, and other human rights issues. Chen said that Taiwanese society needs to discuss human rights in more depth. She added, "In the future, we will learn from France through exchanges and cooperation to stay in step with the rest of the world."

The European Union's representative in Taiwan Filip Grzegorzewski, Head of the European Economic and Trade Office, visited NHRC Chairperson Chen Chu.

The two sides engaged in an extensive discussion on issues including migrant





workers, fishermen, disabled rights. Grzegorzewski praised Taiwan's development of human rights. He added that the EU supported national human rights institutions founded on the Paris Principles and looked forward to closer cooperation with Taiwan.
